- 6. Does he/she have a "Jekyll & Hyde" personality?
- 7. Do you make excuses for your partner's behavior?
- 8. Do you do more of the work paid or unpaid?
- 9. Are you forced to have sex after you've said "no"?
- 10. Do you need your partner's permission to do things?
- 11. Are you punished for misbehaving?
- 12. Was your partner or his/her mother abused?
- 13. Does your partner humiliate you in public?
- 14. Do you live in fear of your loved ones?
- 15. Is there a scene if you disagree with your partner?

IF YOU ANSWERED YES TO:

- 1-2: Take notice and work together to improve troubled areas.
- 3-4: Seriously look at your relationship; seek help from a qualified counselor.
- 5-6: ABUSE Issue; counseling may not be appropriate until FEAR ceases.
- 7-15: CRISIS INTERVENTION NEEDED. Seek individual counseling JOINT THERAPY NOT APPROPRIATE!

FIRST RESPONSE

Cooperating with local law enforcement agencies, Safe Harbour contacts the victim by phone or in person, at the time of the incident.

• LEGAL ADVOCACY

Personal support for victims of domestic violence in criminal and civil court.

IF YOU ARE A VICTIM OF ABUSE, YOU HAVE THE RIGHT TO FILE PETITIONS WITH THE COURT.

A Temporary Protection Order:

If you are a victim of domestic violence and a charge of domestic violence is filed, you have the right to go to court and file a petition requesting an order for a *Temporary Protection Order* which could include the following:

- An order restraining the abuser from further acts of abuse.
- An order directing the abuser to leave your household.
- An order preventing the abuser from entering your residence, school, business or place of employment.

A Civil Protection Order is filed in Domestic Relations Court:

If you are a victim of domestic violence, whether or not a charge is filed, you have the right to go to the Domestic Relations Court and file a petition requesting a *Civil Protection Order* which could include the following:

- An order restraining the abuser from further acts of abuse.
- An order directing the abuser to leave your household.
- An order preventing the abuser from entering your residence, school, business or place of employment.
- An order awarding you or the other parent temporary custody of or temporary visitation with your child or children.
- An order directing the abuser to pay support to you and the minor children if the abuser has a legal obligation to do so.
